Whereas the above bounden principal is the parent of the minor (boy) (hereinafter referred as the student) who has been admitted to the Sainik School Kunjpura, Karnal (hereinafter referred to as the school) for the purpose of receiving education with the object of joining the Regular Armed Forces of India if, considered suitable and selected by appropriate authority at the conclusion of studies in school.

3. And whereas at the request of the Principal the Govt. has agreed to pay to the student for the period of 7 years from, Apr 20.... a yearly scholarship including clothing allowance (if granted) at such rate as may from time to time be sanctioned by the Govt. in respect of fee and clothing etc. on the condition interalla, of the principal and sureties executing a bond.

4. And whereas the above bounden persons have executed the above written bond. Now the condition of the above written bond is that:

(a) The student shall regularly and diligently pursue his studies at the school and take and go on taking National Defence Academy Examination so long his age permits him so to do according to the rules and regulations for the time being in force for entry to the Regular Armed Forces of India, till he is selected therein and when selected the student shall proceed to the institution to which he may be directed for being trained for entry into the Regular Armed Forces.

(b) The Student shall observe and comply with all the rules and conditions regarding the study discipline and conduct as may be prescribed by the authorities of the school from time to time.

(c) The student shall show diligence in the promotion of his studies at school and strictly conform to the rules for the award of scholarship framed by the Govt. and the Instructions which may be issued by the Govt.

(d) That if for any reasons not beyond the control of either the student or the guarantor the student fails to pursue his studies at the said school before appearing for selection for entry to any institution, as may from time to time be prescribed by the Govt. for training for entry to the regular. Armed Forces or fails to appear for the said selection till such time as his age

permits him to do so, according to the rules and regulations for the time being in force or having been declared successful at the said selection does not proceed to one of the said institutions to which he may be directed to proceed for being trained for entry into the Regular Armed Forces of having Forces after completing the training at the said institution then and in any such case the guarantor shall forth will pay to the Govt. in case the sum of scholarship the student has received from the school and/or the State Govt. The value of the scholarship he has received for the period the student was at the said school.

(e) The above bounden principal shall communicate change in his income to the principle of the school immediately.

(f) The student shall not leave the school at any intermediate stage.

or

(g) On default or breach of any the above mentioned conditions, the above bounden persons Shall well and truly pay all money paid to the student on account of scholarship and clothing allowance, if granted, with interest thereon from the date of demand at Govt. Rates for the time being in force on the Govt. loans then the above written bond, or obligation shall be void, otherwise the same remain full force and virtue.

5. Provided always that if it comes to the knowledge of the Govt. that a scholarship or part thereof has been obtained on the basis of false information furnished by the principal the amount of scholarship so obtained shall become immediately re-payable on demand and may be recovered by the Govt. from the Principal and the sureties jointly and severally.

6. Provided further the liability of the sureties under this ground shall not be affected by Govt. giving time or showing any other indulgence to the principal and that Govt. may sure the sureties or and of them before suing the principal. The stamp duty, if any on this document shall be borne by the Government.
